


The stand is not assembled on your unit at time of shipment. You must install it when you receive your unit.

To install the stand on your unit:

- **1.** Position the unit so that its front panel rests on a flat surface such as a table.
- **2.** Using the provided hex key ("Allen" key), remove the two top screws that secure the back of the unit in place.




3. Align the side of the stand blockers with the side of the anchor eyelets, and then slide the blockers towards the eyelets until they stop. There should be no gap between the blockers and the eyelets.



4. Using the provided hex key ("Allen" key), put the two top screws back in place (in the center of the blockers).


5. Hold the stand by its sides, and then slightly widen it to be able to insert it into the blockers.



- **6.** Release the stand as soon as it is properly inserted into the blockers.
- **7.** If desired, secure the stand in its retaining clip by pushing it downwards.

Turning On or Off the Unit

There are several ways to turn off the unit, including the following:

- ➤ Suspend: keeps the unit's status information in memory (RAM). The next time you turn your unit on, you will quickly return to your work environment (running applications will still be running). This mode will take more battery power while the unit is off.

 When powered by battery, the unit will be shut down automatically after four hours in suspend mode.
- Shutdown: completely cuts power to the test instruments and unit; the unit will perform a complete restart routine the next time you use it. You should perform a shutdown if you do not intend to use your unit for a day or more.

After a shutdown, the unit will start in the Home screen or in the application you defined as the startup application.

Note: Should the unit ever stop responding, you can force a hardware reset by pressing and holding down the on/off button for at least 12 seconds. To restart your unit, release the on/off button, and then press it again as you would normally do to start your unit.

When a power outage occurs while the unit is connected to the AC power, the unit will restart automatically when the AC power comes back.

When the unit is in suspend mode and is powered by battery, the unit will remain in suspend mode if you connect the AC power, but the battery LED will light up.

To turn on the unit:

Configuring Your Unit At First Startup

Once the unit will have restarted, the configuration wizard will be displayed in the selected language.




Navigating Through the Applications

The central point on your unit is the Home screen. From there, you can access all the available applications and tools.

Several applications can run simultaneously on your unit, but only one instance of a specific application at a time. You can switch to the last used application, or to the application of your choice easily, without having to close the applications each time.

To start an application:

From the Home screen, tap the icon corresponding to the desired application or tool.

Using the On-Screen (Virtual) Keyboard

Your unit is equipped with an on-screen keyboard that is displayed automatically when you select any location where data entry is possible.

Note: You can close the keyboard temporarily with the button (located in the lower-right corner of the virtual keyboard). Next time you select a location where data entry is possible, the keyboard will be displayed again automatically.

By default, the keyboard layout is set to QWERTY, but you can select any of the provided layouts. You can also hide the virtual keyboard so that it is not displayed when you select a location where data entry is possible. This could be particularly useful when you connect a hardware keyboard to your unit. Installing or Upgrading the Applications

All the necessary applications have been preinstalled and configured at the factory. However, you may have to upgrade the applications when new versions become available. You can either install all the applications at a time using a single system image file, or install specific products using their individual upgrade files.

When updates are available, you can download the new installation files (system image file or specific products) from the EXFO Web site to a computer. You can then transfer the files to your unit with a USB memory key.

You can install new versions of system images or products, or revert to previous ones, but you cannot reinstall versions that are currently installed on your unit.

At the end of the upgrade process, you will be presented with the configuration wizard. By default, the regional and language settings that were in use before the update will be kept, but you can modify them if you prefer.

To install or upgrade the applications:

1. Using your computer, if necessary, retrieve the desired system image file or product upgrade files from the EXFO Web site.



IMPORTANT

If you want to upgrade specific products, ensure that you retrieve both the .bin and .xlm files. Otherwise, the application will not be able to upgrade the product.

2. From your computer, copy the installation files to the root of a USB memory key.



IMPORTANT

- ➤ The application only takes into account the upgrade files (system images or products) that are not already installed on your unit. The other upgrade files will be ignored.
- System image files have precedence over product's upgrade files. This means that if there is a system image (not currently installed on your unit) at the root of the USB key, the application will ignore the upgrade files that may be present for specific products. If you want to upgrade specific products, ensure that there is no system image file at the root of the USB key that could prevent the upgrade.
- **3.** Ensure that your unit will remain powered on during the operation by connecting it to a power outlet using the provided AC/DC power adapter.
- **4.** From your unit, exit all the running applications.
- **5.** Connect the USB memory key to one of the USB ports of your unit.
- **6.** From the Home screen, on your unit, tap **Configuration**.

7. Tap Software Updates.



8. Tap Check for Updates.


Note: If no appropriate system image file or product upgrade files are found on the USB memory key, the application will prompt you to browse for a folder containing upgrade files.

Note: If several versions of the system image or of the products are found, the application will install the most recent version.

9. When the application prompts you to confirm the replacement of the current system image or products with new ones, tap **Yes** (system image) or **Update** (products) to start the process.



10. Read the end-user license agreement (EULA), and if you agree with the terms, tap **Accept**.



Note: The acceptance of the license agreement is mandatory to be able to proceed with the upgrade.

Note: The installation process may take a few minutes.

11. When the application prompts you to restart the unit, tap OK.



CAUTION

It is normal that your unit restarts a few times during the upgrade process.

To avoid causing irreparable damage to your unit, do not turn off your unit or force a power reset during the upgrade process. You will know that the upgrade is over when the configuration wizard is displayed.

12. When the configuration wizard is displayed, follow the on-screen instructions (see *Configuring Your Unit At First Startup* on page 24).

Note: At this point, if you have used a USB memory key to update your unit, you can remove it.

Activating Software Options

The software options purchased at the same time as your unit have been activated for you already. However, if you purchase options afterwards, you will have to activate them yourself.

Before being able to activate options, you need to contact EXFO with the following information:


You will receive a single key (.key) file with which you will be able to unlock all the new options that you have purchased.

If you have several units for which you need to activate options, you can copy all the key files (one file per unit) to the root of a USB memory key and use this USB key with all your units, in turn. If the appropriate key file is present on the USB key, the application will retrieve it, activate the options and then remove the file from the USB key automatically. This enables you to manage the options of all units without having to match the right key file with the current unit.

Note: If you prefer that the key files remain on the USB memory key after the activation of the options, you have to change the attribute of the file to read-only before starting to activate the options.

To activate the options for your unit:

- **1.** From your computer, copy the key file to the root of a USB memory key.

Note: At this point, if you have used a USB key to copy your key file, you can remove it as it is not required to use your new options.



Adjusting Brightness

If you want to set the delay after which the display is dimmed to save power, see *Configuring the Power Management Options* on page 57.

To adjust the display brightness:

- **1.** From the Home screen, tap **Configuration**.
- **2.** Tap **Brightness**.



- 3. Move the slider until the screen appearance is to your liking.
 The new brightness value is taken into account immediately.
- **4.** From the unit's front panel, press the button to return to the Home screen.

To quickly set the brightness to the medium or maximum level:





By default, the dates (short and long), time and decimal separator are displayed in the formats associated with the global language format (locale). This means that by selecting the global language format, you can quickly define date, time and decimal separator formats.

For information on how to refine the date, time or decimal separator formats, see *Setting Date and Time Formats* on page 51 and *Setting the Decimal Separator* on page 52.

To set the global language format:

- 1. From the Home screen, tap Configuration.
- **2.** Tap **Region and Language**.



3. From the **Format** list, select the desired global language (locale). This will determine the date formats available for the dates, time and decimal separator.



4. From the unit's front panel, press the button to return to the Home screen.

The new values are taken into account immediately.


Setting Date and Time Formats

By default, the dates (short and long) and time are displayed in the formats associated with the global language format (locale). The time can be expressed with a 12- or a 24-hour notation. You can modify the way dates and time are displayed if the default values do not suit your needs.

For information on how to adjust the date, the time, and the time zone, see *Adjusting the Date*, *Time and Time Zone* on page 43.

To set date and time formats:

- **1.** From the Home screen, tap **Configuration**.
- 2. Tap Region and Language.



- **3.** Refine the settings according to your needs.
- **4.** From the unit's front panel, press the button to return to the Home screen.


The new values are taken into account immediately.

Setting the Decimal Separator

By default, the decimal separator used in numeric values corresponds to the one associated with the global language format (locale). However, you can select another decimal separator if you prefer.

To set the decimal separator:

- **1.** From the Home screen, tap **Configuration**.
- 2. Tap Region and Language.



3. From the **Decimal separator** list, select the desired separator.



4. From the unit's front panel, press the button to return to the Home screen.

The new value is taken into account immediately.

Changing the Background Picture

The Home screen comes with a default background picture. However, you can change it by either selecting another image from those provided with your unit, or by adding one of your own images.

For an optimum display, the size of the images must be 800 pixels x 480 pixels. The images that are smaller will be ignored (not visible on the list of possible background images). The images exceeding the optimum dimensions will be truncated to the right dimensions automatically at time of display.

You can use images in .bmp, .jpg, or .png format. Your background images are kept in the following folder:

DATA|Home screen|Backgrounds.



IMPORTANT


The unit takes into account *only a limited number of the most recent images* whose sizes are 800 pixels x 480 pixels or more. Adding a large number of images to your unit will have an impact on the loading time of the background images list.

To add your own background pictures:

- 1. Transfer the images that you want to use to a USB memory key.
- 2. Connect the USB memory key to one of the USB ports on your unit.
- **3.** From the Home screen, tap **File Manager.**



4. Tap the parent folder button once.




5. Localize your USB memory key (identified by "Removable Disk" or "Removable Disk 2").



- **6.** Double-tap the USB memory key identifier to access the key contents.
- **7.** Copy the image that you need:
 - **7a.** Select the desired file.

Note: If you want to copy all files at the same time, from the **Edit** menu, select **Select All**.

- **7b.** From the **Edit** menu, select **Copy**.
- **8.** Tap the parent folder button once to exit the USB memory key.
- **9.** Double-tap **DATA**, then **Home screen** > **Backgrounds**.
- 10. From the Edit menu, select Paste.



- **11.** If necessary, repeat steps 6 to 10 with all the images that you want to transfer to your unit.
- **12.** Disconnect the USB memory key.

Your new images are now available on your unit.

To change the background picture:

- 1. From the Home screen, tap Configuration.
- 2. Tap Display.



- **3.** Tap the image that you want to select as the new background image. The edge of the selected image will be highlighted and a check mark will appear, confirming your selection.
- **4.** From the unit's front panel, press the button to return to the Home screen.

The background image is refreshed immediately.

Configuring the Power Management Options

When you do not use the unit for a while, the display may be dimmed to save power. You can also configure the unit to go into suspend (sleep) mode after the specified duration has expired (see *Turning On or Off the Unit* on page 22).

For these actions, you can set idle durations for AC/DC power adapter and battery operation. The values that you set are kept in memory even when you turn the unit off.



IMPORTANT


The sleep delay (time before the unit switches to suspend mode) will only be taken into account once the dim delay (time before the display is dimmed) has expired. For example, if the dim delay is set to 5 minutes and the sleep delay is set to 10 minutes, the unit will switch to suspend mode (sleep) after 15 minutes. If you set the dim delay to *Never*, the sleep delay will also be set to *Never* automatically.

Note: When the unit is in suspend mode and powered by battery, to save battery power, the unit will switch from suspend to shutdown automatically after four hours.

Note: When the backlight is dimmed, the unit operation is not interrupted. Touch anywhere on the screen to return to normal operation.

To configure the power management options:

- **1.** From the Home screen, tap **Configuration**.
- **2.** Tap **Power Options**.



- **3.** Modify the settings according to your needs.
- **4.** From the unit's front panel, press the button to return to the Home screen.

The new values are taken into account immediately.

Configuring the Internet Options

You can browse the Web directly from your unit, provided that you have access to an Internet connection and that the Internet options are configured properly.

If you are not sure about how to configure your Internet access, contact your network administrator.

To configure the Internet options:

- **1.** From the Home screen, tap **Configuration**.
- 2. Tap Devices and Utilities.



- 3. Tap Internet Options.
- **4.** Go to the **Connection** tab.
- **5.** Modify the settings using the information provided by your network administrator.
- **6.** From the unit's front panel, press the button to return to the Home screen.

The new values are taken into account immediately.

Recalibrating the Touchscreen

If you notice the touchscreen does not behave in the way it used to (for example, it is now difficult to select items) it probably needs a recalibration. The calibration method is performed using five points.

You can stop the calibration process at any time, but the touchscreen will still need calibration. The parameters are taken into account only when the process is complete.

Note: If a keyboard is connected to your unit, you can start the calibration application directly by pressing CTRL + ALT + T.


To recalibrate the touchscreen:

- **1.** If you have started the calibration application already, go directly to step 4. Otherwise, from the Home screen, tap **Configuration**.
- 2. Tap Devices and Utilities.



3. Tap Touchscreen Calibration.

4. Using the stylus (or any blunt pointing device), simply press the center of the different targets that appear on the screen.



Note: If you want to stop the calibration process, from the unit's front panel, press the button. The application will close automatically after a few seconds.

- **5.** When the calibration is complete, you will return to the Configuration window automatically.
- **6.** Press the button to close the Configuration window and return to the Home screen.

Selecting the Startup Application


The first time you start your unit, the Home screen is displayed. However, you can configure your unit to automatically start in any of the available applications.

You can also configure your unit to start services such as the VNC server (for remote control) or EXFO Connect Client CE. For more information on remote control with VNC, see *Accessing Your Unit Remotely* on page 121. For more information on EXFO Connect Client CE, refer to the corresponding user guide.

The selected application and service will start automatically the next time you turn on your unit after a *shutdown* (not after resuming from the suspend mode, and not after updating the applications). For more information, see *Turning On or Off the Unit* on page 22.

To select a startup application:

- **1.** From the Home screen, tap **Configuration**.
- 2. Tap Startup Application.



3. Select the application and/or the service you want to start automatically when you turn on your unit.



Note: You can select more than one service, but only one application at a time.

4. From the unit's front panel, press the button to return to the Home screen.

Your selection will be taken into account next time you restart the unit.

Configuring the Network Settings

You can configure the various network settings that your unit uses to connect to the network or to the Internet. By default, the IP address of the unit is assigned dynamically (automatically) by a DHCP server on your network. However, if you prefer, you can define your own static IP address.

Note: If you are not sure on how to proceed or need more information about the configuration, contact your network administrator.

To configure the network settings:

- **1.** From the Home screen, tap **Configuration**.
- 2. Tap Devices and Utilities.




3. Tap Network Connections.

4. Double-tap FEC1.



5. Go to the **IP Address** tab.



- **6.** Modify the settings using the information provided by your network administrator.
- **7.** Tap **OK** to confirm the changes.
- **8.** Close the window to return to the Configuration window.
- **9.** From the unit's front panel, press the button to return to the Home screen.

The new values are taken into account immediately.

Using Password Protection for Your Unit

If you have purchased the PSWRD option, as an administrator, you can set passwords to secure access to your units and applications.

There are two types of passwords:

- ➤ Admin: Allows to open and use the applications, plus manage the password feature settings.
- ➤ User: Allows to open and use the applications.

The user password can remain the same until you decide to modify it, or you can specify an expiration date at which it will need to be changed. You can set passwords individually on each unit, or you can use the export feature once you have set a first unit, and import the settings to the rest of your units. You can also include a short message that will appear on the title bar of the unit once the user or administrator has logged in.

Note: Once you have enabled passwords on your unit, you will need the administrator password to deactivate the feature, or to revert to a previous version of the application and remove the option.



IMPORTANT

You need the product key, located on the provided USB key to enable the software option.



IMPORTANT

As a user, if you lose your password, contact your administrator to retrieve it or receive a new file to import.

As an administrator, if you lose your passwords, contact EXFO for assistance.


To set passwords for your unit (administrator level only):

- **1.** From the Home screen, tap **Configuration**.
- 2. Tap Devices and Utilities.






8. If you want to add a short message on the title bar of the Home screen, enable the corresponding option, then enter your message.



9. If you are setting up only one unit, tap \mathbf{OK} to close the window. OR

If you want to export your settings to other units, tap **Export**. The file will be saved onto the USB key.



You can now import this file on other units, or send it to a user should they require new password information.


To import password settings from another unit (administrator level only):

- **1.** From the Home screen, tap **Configuration**.
- 2. Tap Devices and Utilities.



3. Tap **Security**, then enter the administrator password.

4. Tap **Import**. The most recent file is automatically used.




To clear the password settings (administrator level only):

- **1.** From the Home screen, tap **Configuration**.
- 2. Tap Devices and Utilities.



3. Tap **Security**, then enter the administrator password.

4. Tap Reset.



To log on to the unit:

When prompted, enter your user or administrator password.

If your administrator has provided you with updated password information, for example, if your password has expired or if you have lost your password, tap **Import**, then locate the key file on your USB key to enable the new information. You can then proceed by entering the new password.

Working with Your Unit

Accessing the Online Documentation

You can access the user documentation as well as the license agreements at all times from your unit. When you open user documentation from the Home screen (or the configuration wizard), the PDF files are displayed automatically in the PDF reader.

If you want to print the user documentation, from a computer having access to the Internet, you can sign in to your EXFO account from the EXFO Web site (www.exfo.com) and download it directly. You can also retrieve the user documentation from your unit and transfer the PDF file to a USB memory key.

To access the online documentation:

1. From the Home screen, tap **Documentation**.




2. Tap the desired document.




Note: The available documents depend on your unit's configuration.

3. If you wish to access navigation tools, tap anywhere on the screen to display the tools icon.



4. Tap the control display the **Tools** and **Bookmarks** tabs.




Note: As soon as you switch to full screen mode, only the content of the file remains displayed (all the other elements are hidden). For this reason, to close the PDF reader, you need to go back to the Tools tab (steps 3 and 4 explained above), and then exit the full screen mode with the button. You will then be able to close the reader as usual with the button.

To transfer the user documentation to a USB memory key:

- 1. Connect a USB memory key to one of the USB ports of the unit.
- **2.** From the Home screen, tap **File Manager**.
- **3.** In the **Address** bar, type |*Program Files*|*Metrino*|, and press ENTER.



- **4.** Double-tap the folder corresponding to the application for which you want to retrieve the documentation.
- **5.** Locate the desired PDF file. The English version is available directly at the root of the folder. For the other languages, double-tap the folder corresponding to the desired language.



Note: The user documentation may not be available in all of the listed languages.

- **6.** From the **Edit** menu, select **Copy**.
- **7.** Tap the parent folder button several times until you can see your USB memory key (identified by "Removable Disk" or "Removable Disk 2").



- **8.** Double-tap the USB memory key identifier to access the key contents.
- **9.** From the **Edit** menu, select **Paste**.
- 10. Disconnect your USB memory key.

Taking Screen Captures

You can take captures of what is displayed on your screen, directly from your unit. This could be useful for troubleshooting when you need another person to have a look at a specific configuration or problem. You could also use this tool for training purposes.

For more information on how to modify the default file format and destination folder, see *Setting Storage Parameters for Screen Captures* on page 84.

➤ Images are saved using the defined file format. By default, images are created in .jpg format, but you can modify this parameter. By default, they are kept in the following folder:

|DATA|My Documents|Screenshots

It is possible to modify the folder in which images are automatically saved.

➤ By default, the application generates file names as follows:

IMG_<Selected_date_format>_<Selected_time_format>.jpg where

Selected_date_format corresponds to the short date format defined in the Configuration > Region and Language window.

Selected_time_format corresponds to the time format defined in the **Configuration** > **Region and Language** window.

Examples:

For a screen capture taken on August 20, 2013, the file name could be:

Short Date Format	Time Format	File Name

To take a screen capture:

- **1.** From the unit's front panel, press the button for two seconds.
- **2.** From the shortcut toolbar, tap the button.

The screen capture is automatically taken (a visual effect typical of a camera taking a picture indicates that the capture is complete).

Note: The shortcut toolbar will not appear in the screen capture.

Setting Storage Parameters for Screen Captures

You can modify the file format of the screen captures as well as the destination folder, that is the folder to which the captures will be sent.

- ➤ By default, images are saved in .jpg format, but you can configure the application to save them in .png or .bmp format.
- ➤ By default, images are kept in the following folder:

|DATA|My Documents|Screenshots

You can select any other folder as the destination either locally on your unit, on a USB memory key. If you wish to create your own folders on the unit, use the File Manager from the Home screen.

Note: If the specified folder is no longer available (folder name has been modified, folder has been deleted), the screen captures will be sent to a new folder whose name and path correspond to those of the specified folder. However, if you have defined a destination folder on a USB key and this key is not connected to your unit when you take screen captures, the latter will be sent to the default folder.

To set the default image format:

- **1.** From the Home screen, tap **Configuration**.
- 2. Tap Devices and Utilities.



- 3. Tap Screenshot Configuration.
- **4.** Under **Image format**, select the option corresponding to the desired format.



5. Tap **OK** to confirm the changes and close the window.

To modify the destination folder:

- **1.** From the Home screen, tap **Configuration**.
- 2. Tap Devices and Utilities.



- 3. Tap Screenshot Configuration.
- 4. Under **Destination folder**, tap **Browse**.



5. From the **Browse for Folder** window, select the folder that you want to use to store the screen captures.



- **6.** When your selection is made, tap **OK**.
- 7. Tap **OK** to confirm the changes and close the window.

Browsing the Web

You can browse the Web directly from your unit, provided that you have access to an Internet connection.

If you need to modify the Internet options, see *Configuring the Internet Options* on page 59.

To browse the Web:

1. From the Home screen, tap the **Internet Explorer** icon to open the browser.



2. Enter the desired Web address in the address bar and tap the ENTER key from the on-screen keyboard to start browsing.



3. Press the button or close the window to return to the Home screen.

6 Using the Optional Built-In Power Meter and VFL

You unit can be equipped with an optical power meter to measure absolute power (dBm or W) or insertion loss (dB). The power meter can detect modulated signals (1 kHz, 2 kHz, 270 Hz, and 330 Hz).

Your unit can also include a visual fault locator (VFL) to inspect or identify fibers.

For more information on how to use the power meter or the VFL, refer to the power meter online help. You can access this online help directly from the Home screen (see Accessing the Online Documentation *on page 77*), or by tapping the button from the power meter application.

Note: The appearance of your application may vary depending on the options that you have purchased. The illustrations presented hereafter show the application as it appears when the unit is equipped with a built-in power meter and a VFL.

To access the built-in power meter or the VFL:

From the Home screen, tap the **Power Meter - VFL** icon to open the application.

Inspecting Fibers with a Probe

The fiber inspection probe (FIP) is used to find dirty or damaged connectors by displaying an enlarged view of the connector surface. You can connect an FIP to your unit to view fiber ends.



IMPORTANT

Only the probes of the FIP-400B series are supported on your unit.

Fiber inspections are made using the ConnectorMax2 application. For more information, refer to the ConnectorMax2 online help. You can access this online help directly from the Home screen (see Accessing the Online Documentation *on page 77*), or by tapping the button from the ConnectorMax2 application.

To inspect fibers with a probe:

- **1.** Connect the probe to one of the USB ports on the top panel of your unit.
- **2.** From the Home screen, tap the **ConnectorMax2** icon to open the application.



8 Managing Data

You can copy, move, rename, delete files and folders directly on your unit.

You can transfer files from your unit to a USB memory key or a computer. You can also transfer data from a storage device or a computer to your unit.

Your unit is equipped with the following ports and devices for data transfer:

- ➤ Two USB 2.0 ports to connect a memory key
- ➤ internal Wi-Fi and Bluetooth module (optional) to connect to a wireless network or transfer data via Bluetooth

Viewing Disk Space and Managing Files

To help you manage the data that is stored on your unit, you can easily view the remaining disk space. You can also copy, move, rename, delete files and folders directly on your unit.

To view the free disk space on your unit (DATA partition):

- **1.** From the Home screen, tap **Configuration**.
- **2.** Tap **System Information** > **Capacity**.

The free disk space is displayed under **Data** (\ **Data) space used**.



3. From the unit's front panel, press the button to return to the Home screen.

To manage files or folders on your unit only:

From the Home screen, select File Manager.

To transfer files or folders between your unit and a USB memory key:

Use the Data Mover application to easily transfer files and folders to a USB memory key (see *Transferring Files with the Data Mover Application* on page 115).

Transferring Data via Bluetooth

If your unit is equipped with the optional wireless module (internal), you can transfer data between your unit and a computer using the Bluetooth technology. By default, the Wi-Fi and Bluetooth module is enabled, but not connected to a network or a device.

If you have disabled the module, you must enable it before trying to transfer data via Bluetooth (see *Enabling or Disabling the Wi-Fi and Bluetooth Module* on page 112).

The computer that you use must run Windows, be equipped with a Bluetooth module (or adapter), and be configured properly.

Your unit must be located within a 9-meter area from your computer (limitation of the Bluetooth technology).

If you need to transfer large files (more than 100 MB), use a USB key, or connect to a Wi-Fi or an Ethernet network.

Configuring the Computer

To communicate via Bluetooth, your unit uses mobile device services, which means that Mobile Device Center (Windows Vista, Windows 7, and Windows 8), or ActiveSync (Windows XP) must be installed on your computer.

You can download and install the required application from the Microsoft Web site:

- ➤ ActiveSync for Windows XP: http://www.microsoft.com/en-us/download/details.aspx?id=15
- ➤ Mobile Device Center for Windows Vista 32 bits, Windows 7 32 bits, or Window 8 32 bits: http://www.microsoft.com/en-us/download/details.aspx?id=14
- ➤ Mobile Device Center for Windows Vista 64 bits, Windows 7 64 bits, Windows 8 64 bits: http://www.microsoft.com/en-ca/download/details.aspx?id=3182

To configure the computer:

- **1.** If necessary, download and install Mobile Device Center (or ActiveSync for Windows XP) on your computer.
- **2.** Configure the Bluetooth settings as follows:
 - **2a.** On the computer, from the taskbar, click the Bluetooth icon.
 - 2b. Select Open Settings.
 - **2c.** Ensure that the option allowing Bluetooth devices to find the computer is selected.
 - **2d.** Click **OK** to confirm.

Pairing Devices with Your Unit

After the computer that you intend to use has been properly configured, you can pair (associate) it with your unit.

Once a device has been paired successfully with your unit, it remains paired (that is, ready for data transfer) as long as you do not remove the pairing yourself. Each time you turn on your unit, or resume your work after the unit has switched to suspend mode, the unit will try to establish a connection with the paired devices automatically.

The next time you open the Bluetooth configuration window, only the devices that have already been paired will be shown by default. However, if you prefer, you can scan for all of the devices available in the area (paired and not paired).

If no Bluetooth devices have been paired yet (or if all pairings have been removed), you will see an empty list when you open the configuration window. You can also scan for all available devices.

The icon, displayed in the title bar, indicates the status of the Bluetooth connection. The following table shows the possibilities:

lcon	Meaning
Grey	The Wi-Fi and Bluetooth module is enabled, but no pairing and no choice of mobile service has been made.
Blue	At least one Bluetooth device has been paired successfully with your unit.
Not visible	Unit is not equipped with Wi-Fi and Bluetooth option.
	Wi-Fi and Bluetooth are not supported on this model.
	➤ Wi-Fi and Bluetooth module is disabled (see <i>Enabling or Disabling the Wi-Fi and Bluetooth Module</i> on page 112).

Once the communication is established between your unit and the computer, you are ready to transfer data.



IMPORTANT

To avoid problems, always initiate the pairing *from* your unit (not from the Bluetooth devices).

To pair devices with your unit:

- **1.** On your unit, from the Home screen, tap **Configuration**.
- 2. Tap Devices and Utilities.



3. Tap Bluetooth Configuration.

Note: The **Bluetooth Configuration** icon is only visible on units that support wireless communication, and that are equipped with the optional wireless module.

4. Ensure that the **Enable Wi-Fi and Bluetooth** check box is selected.



5. Tap **Find Devices** if you want to scan for all the Bluetooth devices that are available within your unit's range.



Note: If you do not scan for all the available devices, the application will either show you the list of paired devices, or an empty list if no pairing exist.

6. Tap the row corresponding to your computer.



7. Tap Connect.

Note: Depending on the computer that you are using, the application will either provide you with a passkey, or prompt you to confirm that the displayed passkey matches the passkey used on the computer.

8. If necessary, write down the passkey displayed on screen.

- **9.** On the computer, when the application prompts you, click the Bluetooth icon (located on the taskbar) to display the wizard allowing you to add a Bluetooth device.
- **10.** Follow the on-screen instructions. Enter the passkey that you wrote down earlier, or confirm the correspondence between the two passkeys.

Note: On your unit, if necessary, tap **Yes** to close the passkey window.

Note: Once you have established a secured connection using a passkey, this passkey is kept in memory both on your unit and on the computer until you remove this connection from your unit (**Configuration > Devices and Utilities > Bluetooth Configuration > Disconnect**).

11. Ensure that the row corresponding to your paired computer is selected, and then tap **Settings** to activate the desired mobile service.







The unit tries to establish communication with the computer. Mobile Device Center starts automatically (on the computer).

13. On your unit, tap **Close** to close the Bluetooth configuration window.

You are now ready to start transferring files.

The unit will try to establish a connection with the paired devices automatically next at the next startup, or return from the suspend mode (a connection window will appear briefly).

Transferring Data

Once the Bluetooth communication is established between your unit and the computer, you can either transfer data using a file explorer or the file management feature of Mobile Device Center (both available from the computer).

Note: On Windows 8, you cannot access the folders of your unit from a file explorer. You must use Mobile Device Center to transfer data.

To transfer data from your unit to a computer with Mobile Device Center:

1. On the computer, from Mobile Device Center, click **Connect without setting up your device**.







- 3. Click Browse the contents of your device.
- **4.** Double-click the drive that is identified with "\" to access the folders on your unit.



Note: If you close Mobile Device Center, you may have to open it manually at next startup of the unit or when the unit returns from the suspend mode.

Connecting to a Wireless Network

If your unit is equipped with the optional wireless module (internal), you can connect to a wireless network and benefit from all resources that are available on this network. You can transfer data exactly as you would do from an Ethernet network. By default, both the Bluetooth and Wi-Fi module is enabled, but not connected to a network or a device.

If you have disabled the module, you must enable it before trying to connect to a wireless network (see *Enabling or Disabling the Wi-Fi and Bluetooth Module* on page 112).

Once a connection has been established successfully with a wireless network, your unit remains connected to this network as long as you do not disconnect it yourself.

The networks to which the unit has been successfully connected are identified as "Saved" (favorite networks) and placed at the top of the list of networks. Each time that you work with your unit, it will attempt to connect to the first of the saved networks automatically (if the wireless module is enabled). If a specific saved network is not available, the unit switches to the next saved network on the list automatically.

You can remove saved networks from the list of networks to prevent automatic connections to these networks. If these networks are still in range, they will reappear in the list of networks so that they remain available for manual connection later.

The ; icon, displayed both in the title bar and next to each of the available wireless networks, indicates the strength of the wireless signal.

The following table shows the possibilities:

lcon	Meaning
Entirely grey (in the list of networks)	The wireless network is out of range.
Partially or entirely green	The wireless network is in range of your unit. The number of displayed waves in green reflects the quality of the signal.
Not visible (in the title bar)	Unit is not equipped with Wi-Fi and Bluetooth option.
	Wi-Fi and Bluetooth are not supported on this model.
	➤ Wi-Fi and Bluetooth module is disabled (see <i>Enabling or Disabling the Wi-Fi and Bluetooth Module</i> on page 112).
	➤ The wireless network to which the unit was connected is now out of range.
	➤ The unit is not connected to any wireless network.

By default, your unit supports unsecured networks and networks secured with the WPA2-PSK protocol. This means that you do not have any special configuration to make on your unit before connecting to such networks.

Note: It is also possible to configure other types of protocols to match the type of network that you may have (Advanced configuration tool).

The networks are identified either as "Unsecured" (no protocol) or "Secured" with the protocol that is used. Dimmed rows indicate networks that use a protocol requiring a manual configuration. In this case, you may need to contact your network administrator about the configuration details.

To connect to a wireless network:

- **1.** If it is not already done, share all the required folders on your computer. If you are not sure on how to proceed, contact your network administrator.
- **2.** On your unit, from the Home screen, tap **Configuration**.
- 3. Tap Devices and Utilities.



4. Tap Wi-Fi Configuration.

Note: The **Wi-Fi Configuration** icon is only visible on units that support wireless communication, and that are equipped with the optional wireless module.

5. Ensure that the **Enable Wi-Fi and Bluetooth** check box is selected.





6. Tap the row corresponding to the network that you want to use.

Note: The list of wireless networks is refreshed automatically at regular intervals.

- 7. Tap Connect.
- **8.** If the network is protected by a network key (password) enter it in the corresponding box and tap **OK**.



Note: Since all networks are different, you may also need to configure other parameters before being able to transfer data via Wi-Fi. For information on the configuration specific to your network, contact your network administrator.

As soon as the connection is established, you can start working with the selected wireless network. When you have finished, from the **Wi-Fi Configuration** window, tap **Disconnect** to stop communication with the wireless network.

To define manual configurations:

- **1.** If the network that you want to use requires a manual configuration, on your unit, from the Home screen, tap **Configuration**.
- 2. Tap Devices and Utilities.




3. Tap Wi-Fi Configuration.

Note: The **Wi-Fi Configuration** icon is only visible on units that support wireless communication, and that are equipped with the optional wireless module.

4. Ensure that the **Enable Wi-Fi and Bluetooth** check box is selected.



5. Tap **Advanced** to access the configuration tool. The Wi-Fi Configuration window is closed automatically.



6. Set the parameters as needed.



Note: Depending on the type of protocol that you select, you may have to use security certificates for authentication. For more information on the importation of such certificates in your unit, see Managing Security Certificates on page 114.

7. When the configuration is complete, tap **OK** to close the configuration window.

You are now ready to connect to the wireless network for which you have configured the connection parameters.

Enabling or Disabling the Wi-Fi and Bluetooth Module

By default, the Wi-Fi and Bluetooth module is enabled on units that are equipped with the corresponding option.

However, if you do not intend to transfer files via Bluetooth or to work with a wireless network for a certain period of time, you may wish to disable the module to extend battery life. You may also wish to turn off wireless communication for a while ("airplane mode").

As soon as you disable the wireless module, both the Wi-Fi and Bluetooth capabilities are disabled.

You can enable the module again at any time.

To enable or disable the Wi-Fi and Bluetooth module:

- **1.** From the Home screen, tap **Configuration**.
- 2. Tap Devices and Utilities.



3. Tap Bluetooth Configuration or Wi-Fi Configuration.

Note: The **Bluetooth Configuration** and **Wi-Fi Configuration** icons are only visible on models that support wireless communication, and that are equipped with the optional wireless module.

4. Select the **Enable Wi-Fi and Bluetooth** check box if you want to enable wireless communication, or clear it if you want to disable it.



- **5.** Tap **Close** to return to the Configuration window.
- **6.** From the unit's front panel, press the button to return to the Home screen.

The new selection is taken into account immediately.

Managing Security Certificates


You can import, view, or delete the certificates and private keys that are used for server and user authentication directly from your unit. The security certificates that are required depend on your network configuration. Contact your network administrator for more information.

To manage security certificates:

- **1.** From the Home screen, tap **Configuration**.
- 2. Tap Devices and Utilities.



- 3. Tap Security Certificates.
- **4.** Import, view, or remove the certificates as needed.



5. When you have finished, tap OK.

Transferring Files with the Data Mover Application

You cannot print documents and images directly from your unit. You must use a USB memory key to transfer the files to a computer that has access to a printer. If you need more flexibility and a greater choice of report types, you can also transfer result files to a computer onto which applications such as EXFO FastReporter 2 are installed.

With the Data Mover application, you can copy folders and files from your unit to a USB storage device quickly.

You can retrieve files from the predefined source folders or specify your own folders.

The predefined folder is:

My Documents, which path is |DATA|My Documents

Note: You cannot remove the predefined folders from the list of source folders, but you can remove the ones that you have added.

By default, the application retrieves the files from all the folders appearing on the list of source folders. However, you can specify which folders you want to take into account.

Each time you copy data, the application creates a folder on the storage device. This folder will contain the copied files and subfolders (original folder structure as well as folder and file names are kept).

The application generates folder names as follows:

[YEAR]-[MONTH]-[DAY]_[HOUR]-[MINUTE]-[SECOND]

Example:

For a copy operation requested on September 20, 2013, the folder name could be:

2013-09-20-13_23-01-45.

Note: The HOUR value will appear in a 24-hour format, regardless of your unit's time settings.

To transfer files with the Data Mover:

- **1.** Connect a USB storage device to one of the USB ports.
- **2.** From the Home screen, tap **Data Mover**.



3. Select or clear the check boxes to adjust the folder selection to your needs.



- **4.** If necessary, under **Destination media**, select the desired USB storage device.
- **5.** Tap **Copy**. The files will remain on your unit after the transfer.
- **6.** When you have finished, tap **10.** to exit the Data Mover application.

To manage the list of source folders:

1. From the Home screen, tap **Data Mover**.




2. Tap User Preferences.




- **3.** If you want to add your own folders to the list of source folders, proceed as follows:
 - 3a. Tap Add a Folder.



3b. Select the desired folder, and then tap **OK**.



- **4.** If you want to remove folders from the list of source folders, proceed as follows:
 - 4a. Select the folder that you want to remove.



4b. Tap Remove Folder.

Note: The application will not prompt you to confirm the removal of the folder from the list.

- **5.** When you have finished, tap **Close**. Your changes are reflected automatically. All the newly added folders are selected by default.
- **6.** Tap **1** to exit the Data Mover application.

9 Accessing Your Unit Remotely

You can access your unit remotely from a computer using the TightVNC Client application.

The table below presents the characteristics of this application.

Characteristic	TightVNC Client
Type of connection	Not exclusive; several users can be connected to the unit at the same time (sharing the same session).
Password-protected	Yes; but not mandatory. For a more secure connection, you can define a password on the VNC Server from the VNC Server Properties window. By default, all people that use the TightVNC Client will enter the same password (as defined on the server). Each user to whom you provide the password will be able to connect to the unit via TightVNC.

The control of your unit with TightVNC requires the VNC Server (already installed on your unit) and the TightVNC Client Viewer (that you must install on your computer).

The first time you start the VNC Server on your unit, you may want to define a connection password for increased security. This is not mandatory; you can also configure the VNC Server to allow connections without authentication.

If you want VNC Server to start automatically when you turn on your unit, see *Selecting the Startup Application* on page 62.



IMPORTANT

As soon as you restart the unit (to change the display language, for example), the VNC Server will be stopped and the remote connection with the unit will be lost. You will need to restart the VNC Server locally on the unit before being able to reconnect via VNC.

To be able to connect to the unit using TightVNC, you must:

- ➤ Know the IP address of the unit and provide it in the connection settings on the computer.
- ➤ Know the password (same for all users by default).

This section provides you with the basic information to control your unit with TightVNC.

Configuring the VNC Server

The VNC Server is already installed on your unit. By default, the server is configured to accept secured connections only. This means that you must configure a password before establishing a connection between a computer and your unit.

However, you can modify the desired type of connection if you prefer not to be prompted for a password. You can also modify other connection settings to better suit your needs.



IMPORTANT

If you have configured the VNC Server to start automatically when you turn on your unit, you must stop the Server before being able to modify the VNC configuration.

To configure the VNC Server:

1. From the Home screen, tap **VNC**.



2. From the **VNC** toolbar, tap **Server Configuration**.



3. Select the option that best suits your needs.



- ➤ If you do not want to be prompted for a password when you connect with TightVNC, select **No Authentication**.
- ➤ If you prefer to secure the connection with a password, select **VNC Password Authentication**.

- **4.** If you selected the **VNC Password Authentication** option, define the password as follows:
 - **4a.** Tap the **Configure** button located next to the option.
 - **4b.** Type the desired password.



- **4c.** Tap **OK** to keep the new password.
- **5.** From the **VNC Server Properties** window, tap **OK** to confirm the changes. If you prefer to discard all the modifications that you made (including the password), tap the button.



Installing the TightVNC Viewer on a Client Computer

If the TightVNC Viewer is not already installed on your computer, you can download it from the Web for free.



IMPORTANT

EXFO does not provide licenses for TightVNC Viewer. Always ensure that you are entitled to install it on your computer.

To install the TightVNC Viewer on your computer:

- **1.** Open a Web browser and go to http://www.tightvnc.com/.
- **2.** Download the version of the viewer that corresponds to the operating system that your computer is running.
- **3.** Double-click the file that you have just downloaded to start the installation.
- **4.** Follow the on-screen instructions.

Connecting to Your Unit with TightVNC

Once the TightVNC Viewer is installed on your computer, you are ready to access your unit remotely.

To connect to your unit with TightVNC:

1. Connect both the computer and your unit to the same network and make sure they can "see" each other as network restrictions might prevent them from communicating.

Note: To use an Ethernet network, connect an RJ-45 (network) cable to the unit's RJ-45 port located on its top panel.

- **2.** Turn on both the computer and the unit.
- **3.** On your unit, from the Home screen, tap **VNC**.



4. Write down the IP address.



Note: It may take a few seconds before you can see the IP address.

- **5.** If you have configured VNC Server to start automatically when you turn on your unit, go directly to step 7. Otherwise, from the **VNC** toolbar, tap **Start Server**.
- **6.** From the **VNC** toolbar, tap **Start Server**.



Note: The icon appears in the upper right corner of the Home screen to indicate that the VNC Server is running, and that remote connections can be established with the unit.

7. From your computer, start the TightVNC Viewer.

8. In the **Remote Host** list, type the IP address of your unit that you wrote down at step 4.



Note: The appearance of the TightVNC Viewer window may vary depending on the version of the viewer that you have.

- 9. Click Connect.
- **10.** If the application prompts you for a password, enter it and click **OK** to confirm.

Configuring VNC Server to Start Automatically

By default, the VNC Server is not started automatically when you turn on your unit. However, you can modify this setting. This is especially useful if you need to remotely connect to your unit without having the unit close at hand.

If you want VNC Server to start automatically when you turn on your unit, see *Selecting the Startup Application* on page 62.

10 Maintenance

To help ensure long, trouble-free operation:

- Always inspect fiber-optic connectors before using them and clean them if necessary.
- ➤ Keep the unit free of dust.
- Clean the unit casing and front panel with a cloth slightly dampened with water.
- ➤ Store unit at room temperature in a clean and dry area. Keep the unit out of direct sunlight.
- ➤ Avoid high humidity or significant temperature fluctuations.
- > Avoid unnecessary shocks and vibrations.
- ➤ If any liquids are spilled on or into the unit, turn off the power immediately, disconnect from any external power source, remove the batteries and let the unit dry completely.



WARNING

The use of controls, adjustments and procedures, namely for operation and maintenance, other than those specified herein may result in hazardous radiation exposure or impair the protection provided by this unit.

Cleaning Detector Ports

Regular cleaning of detectors will help maintain measurement accuracy.



IMPORTANT

Always cover detectors with protective caps when unit is not in use.

To clean detector ports:

- **1.** Remove the protective cap and adapter (FOA) from the detector.
- **2.** If the detector is dusty, blow dry with compressed air.
- **3.** Being careful not to touch the soft end of the swab, moisten a cleaning tip with *only one drop* of optical-grade liquid cleaner.



IMPORTANT

Some cleaners may leave traces if used abundantly. Do not use bottles that distribute too much liquid at a time.

- **4.** While applying light pressure (to avoid breaking the detector window), gently rotate the cleaning tip on the detector window.
- **5.** Repeat step 4 with a dry cleaning tip or blow dry with compressed air.
- **6.** Discard the cleaning tips after one use.

Cleaning VFL-Type Connectors

VFL-type connectors are fixed on your unit and can be cleaned using a mechanical cleaner.





WARNING

Verifying the surface of the connector with a fiber-optic microscope WHILE THE UNIT IS ACTIVE WILL result in permanent eye damage.

To clean a connector using a mechanical cleaner:

1. Insert the cleaning tip into the optical adapter, and push the outer shell into the cleaner.

Note: The cleaner makes a clicking sound to indicate that the cleaning is done.

2. Verify connector surface with a fiber inspection probe (for example, EXFO's FIP).

Cleaning the Touchscreen of Your Unit

Clean the touchscreen with a soft, non-abrasive cloth, such as one used for cleaning reading glasses, dampened with water.



CAUTION

Using anything else than water can damage the special coating of the touchscreen.

Battery Safety Recommendations



WARNING

Risk of explosion if battery is replaced by an incorrect type. Dispose of used batteries according to the manufacturer's instructions.



WARNING

Do not throw batteries into fire or water and do not short-circuit their electrical contacts. Do not disassemble.



IMPORTANT

Recycle or dispose of used batteries properly, in accordance with local regulations. Do not dispose of them in ordinary garbage receptacles. For more information, see the section about recycling and disposal in this user documentation.

Recharging the Battery

Note: Depending on the ambient temperature, the charge cycle may be interrupted automatically to prevent any damage to the battery.

The battery in your unit is a lithium-polymer battery.

- ➤ The charge status is shown in the upper right corner of the Home screen.
- ➤ The information about the charge status is also available from Configuration > System Information > Capacity.
- ➤ Finally, the unit indicates the charge status with the LED on its front panel (see *LED Indicator Description* on page 5).



CAUTION

Only charge the battery with the AC/DC power adapter (or the car outlet adapter) provided by EXFO with your unit.



IMPORTANT

- ➤ Batteries are not charged at the factory. You must fully charge the battery before using the unit for the first time. The battery is fully charged after a few hours or when the battery LED indicator stops flashing.
- ➤ The time required to charge batteries depends on various factors such as the ambient temperature.
- ➤ To ensure that the battery functions and charges properly, keep it in temperatures between 10 °C and 40 °C (50 °F and 104 °F). Store it between -20 °C to 60 °C (-4 °F to 140 °F).
- ➤ The battery will not recharge when the ambient temperature is below 5 °C (41 °F) or above 40 °C (104 °F).
- ➤ To optimize the lifespan of the battery, disconnect the unit from the external AC power source once the battery is charged.
- ➤ Do not leave a battery discharged for more than two weeks.
- ➤ After 300 cycles (approximately 18 months of use), you may want to replace the battery with a new one to maintain optimal operation conditions. Otherwise, the operating time might be reduced.



IMPORTANT

- ➤ If the unit will not be used for more than two weeks, ensure that the battery is charged at around 50 % of its capacity, and then turn the unit off (shutdown). For optimum battery performance, follow the recommendations below about battery storage.
- ➤ If you need to store the battery for an extended period of time, place it in a cool dry place, and ensure that it is charged at around 50 % of its capacity. Every three months during the storage period, verify the battery level. Recharge the battery when necessary, so that its charge level remains around 50 % of the total capacity. This will ensure that you get the optimum performance out of the battery.

To recharge the battery:

Connect the unit to a power outlet using the AC/DC power adapter (or the car outlet adapter). The charge cycle will start and end automatically.

Note: If the battery level is very low and the charge cycle does not start immediately, leave the unit connected to the power outlet for a few hours to allow the battery to recharge properly.

Replacing the Battery

Your unit can be powered either by battery or from an appropriate power outlet when used with the provided AC/DC power adapter.



WARNING

- ➤ Your unit uses a lithium-polymer battery with built-in protection that has been especially designed for EXFO. For this reason, you can only replace it with batteries of the same type and model.
- ➤ To avoid damaging your unit, EXFO recommends that you send it to an authorized service center if it requires a battery replacement.
- ➤ However, you can purchase a new battery from EXFO.
 Only trained personnel should replace the battery in your unit.
 To avoid serious injuries as well as irreparable damages to your unit, ALWAYS follow the instructions provided with the new battery carefully.

Installing or Removing the Power Meter and VFL

If your unit was not equipped with a power meter (or a power meter and a VFL) at time of your initial purchase, you can purchase one afterwards and install it yourself.

You may also need to remove the power meter to send it to an authorized service center for recalibration.

Note: If you prefer not to remove the power meter from your unit when a calibration is needed, you can also send the complete unit to the service center.

Note: The illustrations presented hereafter show a power meter and a VFL. The appearance of your test instrument may vary slightly depending on the model that you have purchased.



WARNING

- ➤ To avoid serious injuries as well as irreparable damages both to your unit and your power meter, ALWAYS TURN OFF YOUR UNIT (shutdown mode, not suspend) and DISCONNECT IT FROM THE EXTERNAL POWER SOURCE. For more information on the ways to turn off your unit, see *Turning On or Off the Unit* on page 22.
- ➤ Always use caution during the installation or removal process. Even if the unit is disconnected from its external power source, the battery continues to provide power to certain areas of the unit.
- Be careful not to drop metal objects such as screws inside the unit. These could cause a short-circuit leading to a fire or an explosion.



CAUTION

Electrostatic discharge (ESD) damage can cause complete or intermittent equipment failures.

- ➤ Always use an ESD-preventive wrist or ankle strap when handling the power meter. Ensure that the antistatic strap makes good skin contact and that the end of its wire is grounded properly.
- ➤ Always handle the power meter by the edges of its metal faceplate (where the detector port is located).
- ➤ Never touch the circuit board.
- ➤ Keep any piece of clothing away from the power meter during the handling.
- ➤ Never touch any component inside the unit either with tools or your fingers.
- ➤ Only place the power meter on antistatic surfaces such as an antistatic mat, and quickly put power meters that need recalibration into antistatic bags.




CAUTION

Use only power meters and VFL designed for your unit and approved by EXFO.

To install a power meter:

- **1.** Press and hold the On/Off button a few seconds until the unit beeps once to put it in shutdown mode.
- **2.** Disconnect the unit from its external power source.
- **3.** Put on a wrist (or an ankle) antistatic strap and ensure that the end of its wire is grounded properly.
- **4.** Place the unit vertically so that its front panel is facing you.
- **5.** On the top panel of the unit, locate the protective cover that hides the power meter bay.



6. Using a screwdriver, remove the four screws of the protective cover.

Note: Keep the screws close at hand because you will need them to secure the power meter in place later.


7. Remove the protective cover.




IMPORTANT

Do not discard the protective cover. You will need it to protect the power meter bay if you ever send the power meter for recalibration.

8. By holding the power meter by its faceplate, position it so that the writings are right-side up.



9. Carefully align the power meter with the corresponding bay.



- **10.** Gently slide the power meter into the bay until its faceplate is flush with the edge of the bay.
- **11.** Using a screwdriver, secure the power meter in place with all the screws that you have removed at step 6.


- **12.** Remove your antistatic strap.
- **13.** Connect your unit to an external power source if desired.
- **14.** If it is not already done, turn on your unit.
- **15.** Start the power meter application to ensure that the instrument is working properly.

Note: If the power meter is not detected, this could mean that it is not inserted properly in the unit. In this case, repeat the installation procedure. If the problem persists, contact EXFO.

To remove the power meter for recalibration:

- **1.** Press and hold the On/Off button a few seconds until the unit beeps once to put it in shutdown mode.
- **2.** Disconnect the unit from its external power source.
- **3.** Put on a wrist (or an ankle) antistatic strap and ensure that the end of its wire is grounded properly.
- **4.** Place the unit vertically so that its front panel is facing you.

- **5.** On the top panel of the unit, locate the power meter.
- **6.** Using a screwdriver, remove the four screws of the power meter.




Note: If you have a protective cover for the power meter bay, keep the screws close at hand. You will need them to secure the protective cover in place later.



IMPORTANT

Do not discard the screws. You will need them to secure the power meter in its bay when it is back from calibration.

7. By holding the power meter by its faceplate, gently pull it out of the bay completely.



- **8.** Place the power meter in an antistatic bag.
- **9.** If you have a protective cover, proceed as follows:
 - **9a.** Carefully place the cover over the power meter bay.
 - **9b.** Using a screwdriver, secure the protective cover in place with all the screws that you have removed at step 6.
- **10.** Remove your antistatic strap.
- **11.** Connect your unit to an external power source if desired.
